A RESOLUTION OF THE ATKA CITY COUNCIL REQUESTING FUNDING FROM THE FIRST ALASKANS FOUNDATION COMMUNITY PLANNING AND DEVELOPMENT PROGRAM TO COMPLETE PLANNING AND PRELIMINARY DESIGN OF A CLINIC IN ATKA, ALASKA.

WHEREAS, the existing Atka Clinic was built in 1980 and is now more than 20 years old; and

WHEREAS, the building has a number of deficiencies and lacks sufficient space to support the needs of clinic staff and patients; and

WHEREAS, an assessment of the existing clinic has been completed and several options identified to provide an adequate clinic in Atka; and


WHEREAS, replacement of the Atka clinic is a priority of community member and the City of Atka;

NOW THEREFORE BE IT RESOLVED that the Atka City Council requests a grant in the amount of \$50,000 from the First Alaskans Foundation to provide funds to complete planning and preliminary design of a clinic facility in Atka, Alaska; and

BE IT FURTHER RESOLVED that the Mayor and/or City Administrator are authorized to act on behalf of the City of Atka with regards to this grant request.


