Dear Ms. Cook:

The Native Village of Eklutna's Multi-Use Facility #860055 will terminate on September 30, 2007. Athena Logan and I have continuously made contact with the Council's point of contacts, Patricia Gorman and Daniel Alex regarding your Multi-Use Facility Grant. We have offered our assistance several times to the Council on the conceptual planning project. The Council has had from July 15, 2005 to present to complete their conceptual plan. There has been no response by your Council to our requests of information and no further meetings with Ms. Logan to approve a finalized business plan and site plan checklist per your grant agreement requirements.

The Council has until September 30, 2007 to set up a meeting with Ms. Logan for approval of a finalized business plan. By October 15th a final Financial/Progress Report along with an electronic copy and two hard copies of the finalized business plan and site plan checklist should be sent to me. If the Council does not have this documentation to me by this time the Council will be required to return \$18,465.55 that was paid out to the Council on this project from the time period July 15, 2005 to June 30, 2007.

Per the Council's executed grant agreement, Attachment C – Standard Provisions, "In the event of a default or violation of the terms of the Grant Agreement by the Grantee, The Department may institute actions to recover all or part of the project funds paid to the Grantee. Repayment by the Grantee of grant funds under this recovery provision shall occur within thirty (30) days of demand."
