


## Statement of Interest (SOI) Form

# Non-Federal Match/Cost-Share for Other Federal Infrastructure Grants

The Denali Commission is inviting statements of interest for rural Alaska infrastructure projects in need of local match or non-federal cost share for other federal funding. Many Alaska communities lack the tax base or resources necessary to meet cost share requirements. This opportunity aims to provide financial support to meet local match requirements, enabling infrastructure projects in rural areas that often face challenges in securing funding for critical needs such as energy, healthcare, community wellness, climate resilience, broadband, housing, and sanitation. Please note that transportation projects are not eligible for this opportunity.



#### Overview

The Commission announces the availability of funds for Non-Federal Match for Federal Infrastructure Projects that make small scale community improvements. This announcement commits up to \$7,000,000 for the purpose of this opportunity from funds received from a Legislative Grant from the State of Alaska, appropriated pursuant to the provisions of AS 37.05.316, Grants to Named Recipients, SSLA 2024, SB 187, Chapter 8, Section 4, Page 42, and Line 19, "funding to the Denali Commission for Non-Federal Match for Federal Infrastructure Projects."

Applicants may request up to \$1,000,000 per community for each application submitted through this funding opportunity.

The Commission will consider requests for public infrastructure projects that meet the following criteria:

- The project has already secured federal funding that requires a local match.
- The project is currently applying for or plans to apply for funding that requires a local match.

### **Eligible Project Activities**

Respondents are encouraged to identify specific, shovel-ready infrastructure improvement projects and specify the funding needed for their completion. For projects involving equipment purchases or repairs, no more than 5% of these funds may be used for administrative expenses. For all other projects, administrative expenses are capped at 10% of the total grant award.

Examples of projects activities include but are not limited to the following:

- Renewable energy projects such as solar, wind, or hydroelectric installations; grid modernization
  or resilience projects; energy efficiency improvements in public buildings; rural power
  distribution projects.
- Expanding high-speed internet access in underserved or rural areas, installing fiber-optic networks, or creating public Wi-Fi zones.
- Upgrading communication systems for emergency services, constructing emergency operations centers, or improving disaster response capabilities.
- Building or upgrading schools, healthcare clinics, libraries, community centers, and public safety facilities like fire stations or emergency shelters.
- Affordable housing initiatives, development of senior or low-income housing, and improvements to existing public housing units.
- Construction of solid waste facilities, recycling centers, hazardous waste disposal, or composting systems.
- Building seawalls or levees, floodplain restoration, wildfire mitigation efforts, or retrofitting buildings for climate resilience.
- Construction or renovation of hospitals, mental health centers, addiction treatment facilities, or wellness centers.
- Construction or upgrades to water treatment plants, installation of sewage systems, development of stormwater management facilities, or improvements to drinking water infrastructure.

The cost of repair and upgrade of equipment to a project proposal should not exceed 30 percent of the proposed total project. The Commission will consider funding requests for activities that:

- Demonstrate project readiness
- Support planned land use, local or regional plans, and the pursuit of housing and economic development opportunities
- Improve community health. safety, and sustainability
- Expand public facilities in underserved areas
- Protect ecologically sensitive, erosive, or potentially erosive sites
- Improve system resiliency to extreme climate trends and natural disasters

## **Applicant Eligibility**

Eligible projects must benefit the public in Alaska. Eligible applicants include municipal, borough, and tribal governments; Indian Tribes as defined by Title 25 US Code § 5304; regional tribal non-profit organizations; regional housing authorities; and other non-profit organizations.

Entities which do not have an active or pending award with the Denali Commission will be prioritized under this funding opportunity.

### **Review and Evaluation Process**

The Commission will evaluate statements of interest on a rolling basis. A review committee of Commission staff and subject matter experts will conduct a conformance review and evaluate statements according to the priorities listed above, beginning to invite successful respondents by about January 15 to submit applications. Invitations for applications will give interested parties approximately 45 days to respond with a full proposal. Commission staff and subject matter experts will evaluate full applications. The Commission hopes to make awards in late spring 2025 but it's possible the application review and award notification process could take longer and awards may not be executed until fall 2025. The Commission reserves the right to partially fund projects, subject to the quality of funding assistance requests received and other relevant considerations.

This funding opportunity is expected to close February 28, 2025.
